All papers will be evaluated anonymously, for that purpose, they will be required not to be merely descriptive, but to include an analysis that explains objectives and a specific methodology.

To obtain the certificate of participation in the V CIED, the papers must be presented by, at least, one of the authors in the corresponding thematic line sessions. The papers that are not presented at the conferences will not receive the corresponding certificate.

A digital copy of each paper will be included in the Conferences Proceedings, prior authorization of the authors. In addition, only those papers that come in the requested format and have been presented in the parallel sessions of the conference will be included.

The papers presented in Spanish and Basque will also include a summary in English.

To facilitate the edition of the Conference Proceedings, the papers must conform to the editing rules detailed below.

Editing rules

- Maximum extension: 25 pages (including bibliography, annexes, graphics, etc.).
- Configuration of the page
 1. Margins (upper, lower, left and right): 2.5 cm.
 2. Line spacing: 1.15 lines
 3. Numbering at the bottom of the page

If the reference is textual, the text must be enclosed in quotation marks and the page must be indicated in the reference (UNDP, 1990, 20).

In the corresponding section (References) will be indicated the details of the complete works, arranged in alphabetical order, and according to the following format:
